

November 9, 2021

The Board of Supervisors met at 9:00 o'clock A.M. with Jeri Vogt, Chairperson presiding. All Members were present.

Minutes of the previous meeting were read and approved.

On motion, the Board recognized claims for the Public Health Department and approved claims for all other departments.

The Board approved the hiring of Nolan Schmidt, Maintenance Employee IV in the Engineer's Department.

The Board approved the change of status for Andrew Vary, Maintenance Employee I in the Engineer's Department.

The Board discussed adopting FEMA Floodplain Management Measurers to meet NFIP requirements.

No action was taken at this time.

The Board met with Steve Mumm, to discuss Westside Fire & Ambulance Service. Currently CCMH is used as the ambulance service for calls in Westside's Fire District. Westside Fire would like to use Carroll County Ambulance rather than CCMH so that wait time for patients is expedited. All Supervisors were in favor of the change as long as Carroll County Ambulance was in favor of it.

A motion was made by Heiden, seconded by Schultz to set time, date and location for a public hearing regarding a budget amendment for FY 2021-2022 for November 30, 2021 at 10:00 o'clock A.M. in the Board of Supervisors Board Room on the Second Floor of the Courthouse.

Motion was approved unanimously.

A motion was made by Schultz, seconded by Heiden to approve the Consultant Contract for Inspector Services of the Midwest Carbon Express CO2 Pipeline with Sundquist Engineering.

Motion was passed unanimously.

A motion was made by Schultz, seconded by Rosburg to approve the proposals from GSS Inc. for the tower site surveys.

Motion was passed unanimously.

A motion was made by Schultz, seconded by Rosburg to amend the previous motion to approve the proposals from GSS Inc. for the tower site surveys, pending the County Attorney's approval.

Motion was passed as amended.

The Board canvassed the votes cast in the City/School Election held on November 2, 2021. Copies of the canvass and abstracts are available in the Auditor's Office.

During Citizen's Input, John Granzen thanked the Board for their work on the LMR project. Dan Mundt talked about Westside Fire using Carroll County rather than CCMH for ambulance service, pointing out that CCMH is not governed by the county.

On motion duly seconded the Board adjourned at 12:07 o'clock P.M.
