The Board of Supervisors met at 9:00 o'clock A.M. with Kyle Schultz, chairman presiding. Members present were Rosburg, Vogt, and Schultz. Members present on Zoom were Heiden and Skoog.

Minutes of the previous meeting were read and approved.

On motion, the Board recognized claims for the Public Health Department and approved claims for all other departments.

The Board approved the Clerk of Court Fees for October 2022.

A discussion was made with Kaylee-Turn Key Logistics, Kylie-Pipeline Project Manager, and Riley, about the Summit Carbon Solutions Pipeline project update.

NOW, THEREFORE, be it resolved by the Board of Supervisors of Crawford County, Iowa that

The sum of Seven Thousand Dollars (\$7,000.00) is hereby transferred from the Self-Insurance Fund (#8500) into the Wellness Fund (#4020).
