

February 14, 2023

The Board of Supervisors met at 9:00 o'clock A.M. with Ty Rosburg, chairman presiding. Members present were Schultz, Dozark, Rosburg, Muhlbauer, and Heiden.

Minutes of the previous meeting were read and approved.

On motion, the Board recognized claims for the Public Health Department and approved claims for all other departments.

A motion was made by Schultz, seconded by Dozark to approve the Contract, Bonds and Certificate of Insurance with Graves Construction Co., Inc. in the amount of \$1,158,234.65 for the construction of Bridge Replacement Project BRS-C024(129)--60-24. L51 Bridge over the Soldier River.

Motion was passed unanimously.

A motion was made by Heiden, seconded by Dozark to approve the assigning County Held Tax Certificates and Tax Abatement for Parcels #1302378010, #1302378011, and #1302378012 to Sherri Vaughn.

Motion was passed unanimously.

A motion was made by Muhlbauer, seconded by Heiden to approve the following resolution:

A RESOLUTION TO WITHDRAW FROM THE ARTICLES OF AGREEMENT WHICH FORMED THE WORKFORCE DEVELOPMENT CHIEF ELECTED OFFICIAL CONSORTIUM FOR THE WORKFORCE INNOVATION AND OPPORTUNITY ACT OF 2014

Resolution 2023-14

WHEREAS, Crawford County previously signed a resolution to approve the Articles of Agreement creating the Workforce Development Chief Elected Official Consortium (CEO) together with 17 other counties in western and southwestern Iowa, known as the "Western Iowa Workforce Development Area" or WILWDA; and,

WHEREAS, this 28E Agreement was filed with the Iowa Secretary of State on July 7, 2020 and assigned filing number M512796; and,

WHEREAS, Article 13 of the Agreement allows counties, at their sole option, to withdraw from the Agreement at least 90 days prior to the beginning of the fiscal year (April 1 or any year); and,

WHEREAS, at their meeting on January 20, 2023, the CEO Board discussed the 28E Agreement, weighing the roles and responsibilities of counties as a result of the Agreement and impacts to services offered to their citizens both under the agreement and in absence of the Agreement; and,

WHEREAS, the CEO Board voted 11-0 at this meeting, after this discussion, to dissolve the 28E Agreement.

NOW, THEREFORE BE IT RESOLVED by the Crawford County Board of Supervisors that:

1. It does hereby invoke Article 13 of the Articles of Agreement which formed the Workforce Development Chief Elected Official Consortium for the Workforce Innovation and Opportunity Act of 2014 and withdraws from the Agreement at the end of the day June 30, 2023.
2. It understands and is its intention withdrawal of the Agreement by all 18 counties will terminate the Agreement.

Voting Aye was Schultz, Dozark, Rosburg, Muhlbauer, and Heiden. Motion passed unanimously.

A motion was made by Schultz, seconded by Muhlbauer to set the Public Hearing for Property Tax Levy for March 7, 2023 at 10:00 A.M. in the Board of Supervisor's Board Room on the Second Floor of the Courthouse.

Motion was passed unanimously.

A motion was made by Heiden, seconded by Muhlbauer to approve the request from Jill Wonder, Plains Area Mental Health Center, for \$10,325.00 from the Crawford County Opioid Settlement Funds for Substance Use Disorder prevention, Education, and Awareness.

Motion was passed unanimously.

A motion was made by Schultz, seconded by Heiden to approve the Conservation Board's Annual Report presented by Chris Gosch, Director of Conservation.

Motion was passed unanimously.

A motion was made by Muhlbauer, seconded by Dozark to approve the Annual Report for Historic Preservation Commission presented by Amy Pieper.

Motion was passed unanimously.

A motion was made by Dozark, seconded by Heiden to approve the Globe Life Information to be attached to payroll checks to solicit our employees.

Motion was passed unanimously.

During Citizen Input there were citizens here to express their concerns about the pipeline and possible ordinances, litigation, and safety.

At 11:22 o'clock A.M., a motion was made by Heiden, seconded by Dozark to open the Closed Session Pursuant to Iowa Code 21.5(1)(c) in re Hazardous Liquid Pipeline Ordinance. Motion was passed unanimously.

At 12:15 o'clock P.M., a motion was made by Heiden, seconded by Schultz to close the Closed Session. Motion was passed unanimously.

On motion duly seconded the Board adjourned at 12:16 o'clock P.M.
