The Board of Supervisors met at 9:00 o'clock A.M. with Jean Heiden, chair presiding. Members present were Schultz, Dozark, Heiden, Muhlbauer, and Rosburg.

Minutes of the previous meeting were read and approved.

On motion, the Board recognized claims for the Public Health Department and approved claims for all other departments.

Ben Schaben, Assistant to County Engineer, spoke with the board about the award of project BRS—C024(131)—60-24, concrete box culver on County Rd E16 to Dixon Construction Co. in the amount of \$874,128.06. The contract wasn't available during this time. No action was taken.

A motion was made by Schultz, seconded by Dozark to approve the following resolution:

RESOLUTION 2024-7
Detour for Closing A Numbered Route

WHEREAS, Section 306.41 of the Code of Iowa 2014, provides that any County numbered road, closed for over forty-eight hours, shall have a designated detour route, and

WHEREAS, Construction Project BRS-C024(131)--60-24 will require that County Route E16 (AKA D Ave.), between 120th St. and 130th St. be closed to all traffic for several weeks because of a bridge replacement project.

NOW THEREFORE BE IT RESOLVED by the Crawford County Board of Supervisors that the following described route be designated as a DETOUR and that signs be erected accordingly for the duration of the construction, as determined by the County Engineer:

The DETOUR shall commence at the junction of County Route E16 (AKA D Ave.) and County Road L37 (Teak Ave.) in Monona County, thence North 4.2 miles on County Road L37 to County Road D54 (AKA 330th St.) in Woodbury County, thence East 7.4 miles on County Road D54 to County Road L51 (AKA Eagle Ave.) in Ida County, thence South 4 miles on County Road L51 to County Road E16 (AKA D Ave.) in Crawford County.

BE IT FURTHER RESOLVED that upon completion of the construction work, as determined by the County Engineer, the DETOUR shall be terminated without further action by this Board.

Voting Aye: Schultz, Dozark, Heiden, Muhlbauer, and Rosburg. Motion was passed unanimously.

Riley Gibson, Turnkey Logistics, from Summit Carbon Solutions gave the Board an update on the pipelines.

Paul Plumb, Executive Director, of Chamber and Development Council of Crawford County, and Stephanie Wiese, CDC Board President, met with the board to request funds for the Chamber and Development. No action was taken at this time.

Joe Langel and Keith Duncan from Holmes Murphy Insurance, spoke to the Board (via Zoom) about some services that will benefit the county and employees.

A discussion was made by the Board to set a time and date for a public hearing on land rent auction for the Crawford County Farm. No action was taken at this time.

On motion duly seconded the Board adjourned at 11:29 o'clock A.M.
